#### Introduction

The Index of Carpet Names is a voluntary industry scheme for registering names given to carpet qualities. The Index is a computer-based register and has been published since 1983.

The Index system permits more than one name to be assigned to a particular carpet construction. Hence, a carpet construction may attract one or a greater number of names, depending upon the marketing practices of the individual Participant. A carpet construction may therefore be known as several carpet qualities.

## **Purpose of the Index**

The purpose of the Index is to:

- provide a convenient method of preventing duplication of carpet quality names in the Australasian carpet market;
- enable industry members to determine the supplier of a named carpet quality;
- provide a trade standard so that the practice of registering carpet quality names is a matter of course for the industry.

The Index serves as a means by which a company may show, in an evidentiary sense, that a carpet name, which it uses to market a particular quality, has been attributed to it.

In addition, the Index serves to record the Australian Carpet Classification Scheme (ACCS) ratings for carpet constructions, which Licensees of that Scheme are required to warrant.

## Participation

The Index is open to any supplier to the Australian and New Zealand carpet market and is administered by the Carpet Institute of Australia. See Participant Application Form attached. ## Australian Carpet Classification Scheme (ACCS) Gradings

The ACCS has a two label system where a carpet is graded for either Residential application or Contract/Commercial market application (and sometimes both). The residential label features a six-star (6\*) system. The more stars the better durability and appearance retention properties of the graded carpet. The contract/commercial label has a four-star (4\*) grading system.

#### **Stairs Rating**

The stairs column in the Index indicates whether the carpet is suitable for use on stairs. However carpet installed on stairs is subject to severe wear which may result in a significantly shorter performance.



## **ACCS Environmental Certification Scheme**

To carry the ECS label a textile floor covering must have a current ACCS 'durability and appearance retention' grading and pass environmental performance criteria. In addition the licensee must comply with a Code of Practice for Environmental Management.

ECS awards 4 levels of certification, 3 of which are recognized by the Green Building Council of Australia's Green Star rating Scheme, as follows:

## **Rules and Naming Conventions for Registration**

Index Participants cannot register a name if it has already been registered by another Participant authorised by the Carpet Institute of Australia as a Participant.

Participants cannot register a name with a number before or after it, if a name without those numbers is already registered e.g. "Laser 240" is inadmissible if "Laser" is already registered to another Participant.

Participants cannot register a name, which is a variant of a currently registered name by reason of the addition or subtraction of prefixes, suffixes, the singular or the plural to an already registered name.

Names which describe a production process or which denote accepted industry descriptions of particular types of carpets e.g. WILTON, BERBER, TUFTED, ALL NATIONS, WOOL TUFTED etc; will not be registered unless the name is a registered trade mark. The inclusion of a name in the Index is also taken to cover the same name combined with any usual prefix e.g. EXTRA, SUPER, EXTRA SUPER, and/or any similar suffix e.g. if "Laser" is registered to a Participant, then "Super Laser" cannot be registered to another Participant. However, an adjective, adverb or noun, which modifies a name will be permitted unless it is deemed by the Institute in its absolute discretion to be misleading or inappropriate.

If a retailer or retailers to whom a Participant has sold a carpet quality is using a name not registered in the Index, the Participant concerned must register any alternative names so used or seek for the use of those alternative names to be discontinued.

A name may only be registered where there is a product on the market at the time of application to register or where the Participant intends to market the carpet quality within 8 weeks following the date of application.

A Participant must not knowingly register a name, which may possess or attract a superior proprietary interest held by another company (such as trademark or similar protection). Where such a name is improperly registered in the Index, the Institute will upon notification move to alter the Index by removing or properly attributing the name.

The Carpet Institute of Australia at its absolute discretion may refuse to register a name, which it deems to be sufficiently similar to a currently registered name.

The Carpet Institute of Australia may in its absolute discretion interpret these rules or any of them in any manner, which it believes to be reasonable and no right of appeal to any authority will be taken by a Participant.

#### How to become a Participant in the Index of Carpet Names

The Index is open to any supplier to the Australian and New Zealand carpet market and is administered by the Carpet Institute of Australia.

A completed application form must be sent to the Executive Director of the Carpet Institute of Australia. Once approved, you will be asked to sign and return the Rules together with the joining fee. Names will not be registered prior to receipt of signed rules and payment.
